Agreed Value – You select the value per tonne for each crop. You are then guaranteed this value in the event of a claim.

Reducing Excess – The excess gradually reduces when the claim exceeds 20% of the sum insured. The larger the claim, the less the excess you pay

This table highlights the advantage of a reducing excess compared to a flat excess which most other polices have.

Figures are based on a Sum insured of \$100,000. The left hand column represents the amount of damage. The other columns show how claim would be settled.

Extra Harvest Allowance – For claims over 70% of the sum insured that are not a total loss. CGU will top up the claim with half the difference between the % loos and 70%. For example, if your crop suffers 90% damage, they will pay you 100%

Straying Stock – covers damage to your growing crops up to \$100,000 as a result of straying livestock.

Chemical Overspray – \$100,000 cover as a result of damage from chemical overspray within 2km on non owned adjoining property. Also cover for spraying done by independent contactors on your property.

Stored Crop – \$100,000 coverage for damage by wind or water to harvested seed/hay stored in a fully enclosed silo. \$10,000 coverage for loss or damage by wind or water on stored crop held in a grain sock, silo bag or grain bunker

Transit & temporary removal – \$100,000 cover due to accidental loss or damage, including contamination during transport.

Temporary Removal - \$100,000 cover in place. Limited for damage caused by wind & water to \$10,000

- Harvested seed is covered at property
- Harvested seed is covered in transit
- Standing Straw is covered after harvest
- Resowing subsidy included
- Payment of premium after harvest
- Protection from first emergence
- Automatic cover for current season's crops for those who ere insured in previous season




On-line System Access
